Programs--TL

TL referred to the ArtSeen program in which 4 other Maritime galleries are involved and is the first of its kind in Canada. ArtSeen endeavors to provide on-line art-related programming by video recording Artist Talks, Artist's Bios and other art-related endeavors which are then available on the ArtSeen Webpage.

It was suggested that a Curriculum of Programs and Resources be distributed to Elementary and High School in the district.

Elaine Berman commented on the success of the Life Drawing Program and that she has been encouraged by the number of people who visit the gallery.

Proposed By-Law Amendments

By-Law #21 has been amended to "...the number of Directors shall not be fewer than five (5) or more than ten (10)

Motion to Accept change to By-Law #22--Moved by SB, 2nd EB, Carried

By-Law #22 has been amended to "...A Member may sit on the Board for **no longer than six (6)** consecutive year. The Board Chair may sit as Chair for four (4) consecutive years.

Motion to Accept change to By-Law #25--Moved by EB, 2nd JR, Carried

By-Law #25 has been amended to "...Directors shall be eligible for re-election subject to the six (6) year limit as noted in clause #22 above.
